- 3) The number of mobile phones confiscated from Buckley Hall Prison grounds retained by police for investigation purposes in the past 12 months.**
- 4) The number of sim cards confiscated from Buckley Hall Prison grounds retained by police for investigation purposes in the past 12 months.**
- 5) The number of mobile phones seized from prisoners at Buckley Hall Prison retained by police for investigation purposes in the past 12 months.**
- 6) The number of sim cards seized from prisoners at Buckley Hall Prison retained by police for investigation purposes in the past 12 months.**

Following receipt of your request searches were conducted within Greater Manchester Police to locate information relevant to your request. I can confirm that the information you have requested is not held by Greater Manchester Police.

COMPLAINT RIGHTS

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require Greater Manchester Police to review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision of Greater Manchester Police made under the Freedom of Information Act 2000 regarding access to information, you can lodge a complaint with Greater Manchester Police to have the decision reviewed.
