I write in connection with your request for information received by GMP on the 16<sup>th</sup> September 2010. I note you seek access to the following information:-

**Q1. Please provide the number of diesel vehicles currently operated by the Police department and the number of occasions any of these vehicles has been misfilled with petrol requiring unscheduled servicing during each of the last two years.**

**Q2. Please provide the total direct cost associated with the mis-fuelling events.**

**Q3. If the motor vehicles are owned/maintained by a leasing company please provide the name of the leasing company.**

**Result Of Searches**

Following receipt of your request searches were conducted within Greater Manchester Police to locate information relevant to your request. I can confirm that some of the information you have requested is held by Greater Manchester Police.

Question 1, the number of diesel vehicles currently operated by Greater Manchester Police is 1,465. Mis-fueling of vehicles is nil.

Question 2, as there has been no vehicles mis-fueled; Greater Manchester Police do not hold information in regards to this question.

Question 3, in regards to this question none of the vehicles are owned or maintained by a leasing company.

## **COMPLAINT RIGHTS**

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require Greater Manchester Police to review their decision.

### **Ask to have the decision looked at again –**

### **Complaint**

If you are dissatisfied with the handling procedures or the decision of Greater Manchester Police made under the Freedom of Information Act 2000 regarding access to information, you can lodge a complaint with Greater Manchester Police to have the decision reviewed.
