I write in connection with your request for information dated 22/11/2010, which was received by Greater Manchester Police on 23/11/2010. I note you seek access to the following information:

1/ Who pays for the police pensions, is it part of the GMPA budget, is there a separate pot?

2/ What happens to the money paid in by officers as their pension contribution?

in relation to 1/ above please treat any lump sum as part of the question

***Clarification for Q 2 ***

My question is the salary contribution by officers does it go into a separate pot or does it all just get ploughed back in the GMP budget and then paid out again for pension.

Following receipt of your request searches were conducted within Greater Manchester Police to locate information relevant to your request. I can confirm that the information you have requested is held by Greater Manchester Police.

Response

Police Authorities, i.e. GMPA, operate a separate pensions account, into which are paid Officer's and employer's contributions. Any deficit is topped up with a grant from Central Government likewise any surplus is recouped.

COMPLAINT RIGHTS

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require Greater Manchester Police to review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision of Greater Manchester Police made under the Freedom of Information Act 2000 regarding access to information, you can lodge a complaint with Greater Manchester Police to have the decision reviewed.
