FREEDOM OF INFORMATION REQUEST REFERENCE NO: XXXX

I write in connection with your request for information dated 03/01/2011, which was received by Greater Manchester Police on 04/01/2011. I note you seek access to the following information:

How many police community support officers (PCSOs) employed by Greater Manchester Police (GMP) work in the Wigan borough?

What was the total cost of wages for PCSOs in the Wigan borough in the periods 1 April 2009 to 31 March 2010, 1 April 2008 to 31 March 2009 and 1 April 2007 to 31 March 2008?

Following receipt of your request searches were conducted within Greater Manchester Police to locate information relevant to your request. I can confirm that the information you have requested is held by Greater Manchester Police, (GMP).

Responses

The Wigan division of GMP has an establishment of 80 PCSOs, however at this present time there are 78 in post.

The salary costs are 2007/08 = £1,915,085 2008/09 = £2,002,399 and 2009/10 = £2,156,366.

The above figures include basic salary, shift allowances, national insurance and superannuation.

COMPLAINT RIGHTS

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require Greater Manchester Police to review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision of Greater Manchester Police made under the Freedom of Information Act 2000 regarding access to information, you can lodge a complaint with Greater Manchester Police to have the decision reviewed.
