I write in connection with your request for information dated 27/11/2023, received by Greater Manchester Police (GMP) for the following information:

- 1) A list of all offences that were resolved with a police caution in the years 2020 to present.**
- 2) Please include the number of cautions that were issued for each offence in each year.**
- 3) Please provide the data in such a way that makes clear if each caution given for each offence in each year was a youth caution or adult caution.**

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.
