I write in connection with your request for information dated 25/02/2023, received by Greater Manchester Police (GMP) for the following information:

1. How many men and women have reported the following crime - Administering a substance with intent to commit a sexual offence between January 1st, 2021, to 30th November 2022?
2. Please can you specify the age of these men and women who have reported this specific crime.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Over the period in question there was a total of 93 crimes in this category. 76 of these were female victims and 17 were male victims. The breakdown by age range can be found in the table below.

COMPLAINT RIGHTS

Complaint
