FREEDOM OF INFORMATION REQUEST REFERENCE NO: GSA 770/23

I write in connection with your request for information dated 08/02/2023, received by Greater Manchester Police (GMP) for the following information:

1. *The numbers of incidents and crimes on Fallowfield Drive, Rochdale for the period 1st July 2021 to 7th February 2023.*
2. *The numbers of incidents and crimes on Fallowfield Drive, Rochdale for the period 1st July 2019 to 30th June 2021.*

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

Incident data

- This data contains incidents with a created date between 1st July 2019 and 7th February 2023 where the location street contains FALLOWFIELD DRIVE, excluding incidents with a closing code of L10 Duplicate, L19 Error or L22 Test or training.

Crime data

- This data contains crimes with a created date between 1st July 2019 and 7th February 2023 where the location street contains FALLOWFIELD DRIVE, excluding cancelled crimes. Further information about cancelled crimes can be obtained from the Home Office Counting Rules.
