Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

- This data contains crimes recorded under Home Office codes provided by the requester with a created date between 1st April 2019 and 31st March 2022, excluding cancelled crimes. Further information about cancelled crimes can be obtained from the Home Office Counting Rules.
- Crimes with an outcome of 1 Charged/Summoned or 1A Charged/Summoned Alternative Offence has been provided for "crimes investigated which resulted in a charge". All crimes are investigated to some extent so the number of crimes is the same as the number of investigations.
- HO codes 125/58, 125/61 and 125/63 were repealed in 2010 and replaced with code 125/82 so this has been included in the response table.

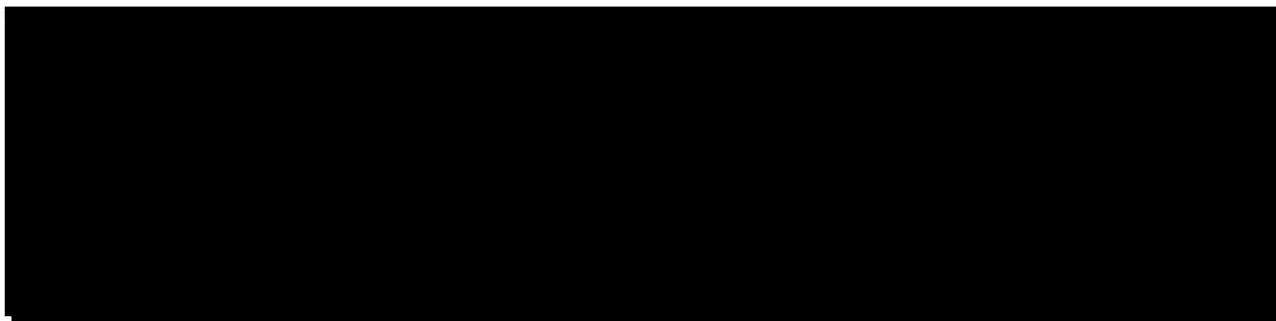
