2. I want information on reports of domestic burglary and separately business burglary

I would like information on a day-by-day basis for each day from November 1 - January 31.

I want a separate table for each year for each of the last 10 years.

3. I want information on public disorder offences

I would like information on a day-by-day basis for each day from November 1 - January 31.

I want a separate table for each year for each of the last 10 years.

4. I want information on fraud reported: break down into different categories of fraud

I would like information on a day-by-day basis for each day from November 1 - January 31.

I want a separate table for each year for each of the last 10 years.

5. I want information on drunk and disorderly conduct, or public disorder offences

I would like information on a day-by-day basis for each day from November 1 - January 31.

I want a separate table for each year for each of the last 10 years.

6. I want information on drink driving offences, of alcohol-involved traffic accidents.

I would like information on a monthly basis

I want a separate table for each year for each of the last 10 years.

7. I want information on the number of assaults.

I would like information on a monthly basis for the whole year.

I want a separate table for each year for each of the last 10 years.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

This data contains crimes with a created date between 1st November and 31st January between 2014 and 2024, excluding cancelled crimes. Further information about cancelled crimes can be obtained from the Home Office Counting Rules.

Due to low numbers returned per assault offence, the totals have been merged as by providing all this information split by specific assault offence would significantly increase the likelihood of identifying the individual(s) concerned, and as such the exemption under S40(2) – Personal Information, would be engaged and result in information being refused. By merging this data, it can be provided in its entirety.
