- 2. Please can you also provide a breakdown of the gender for who is reporting the offence of stalking and harassment from January 1st, 2022, to November 1st, 2023?*
- 3. Please can you provide the outcome of each of these reports of stalking and harassment between the set dates.*
- 4. Please can the information above be presented in an Excel Spreadsheet.*

Result of Searches

Caveats

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

- The time period relates to when the crime was recorded and not when the incident occurred.
- Where possible duplicates have been removed.
- Please note the Outcome figures are correct at the time the report was produced.
