I write in connection with your request for information dated 18/09/2024, received by Greater Manchester Police (GMP) for the following information:

Thanks for this response. Please could I narrow the scope of question 4, as allowed under section 12 of the FOIA when a question is rejected on cost grounds.

I would like to change question 4 to:

- Please could the force provide me with the call log data or a summary of the NCHIs recorded by the force between May 3, 2024 and June 3, 2024 (one month).

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP. However, I am not obliged to supply you with the information as an exemption applies.

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies. The information you have requested is exempt from disclosure by virtue of the following exemption: **Section 40(2) – Personal Information.**

Where redactions occur in the below table, this represents information that identifies a living individual, to disclose this information would breach the principles of the GDPR and the Data Protection Act 2018. Personal data is defined by Article 4 of the GDPR and Part 1 of the Data

Protection Act 2018 and means any information relating to an identified or identifiable natural person ('data subject'). An identified natural person is one who can be identified directly or indirectly from that data.

In accordance with the Section 17 of the Freedom of Information Act 2000, this letter acts as a Refusal Notice for those specific pieces of information.

CAVEATS

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

This data contains crimes with a created date between 03/05/2024 and 03/06/2024, excluding cancelled crimes. Further information about cancelled crimes can be obtained from the Home Office Counting Rules

Crime MO Description
A member of the public has seen posts on social media which are aimed at a wide audience. The posts uses derogatory words and languages towards transgendered and LGBTQI+ persons.
complainant has been insulted by the subject who is a staff member in a shop. Complainant believes that this is because she is spanish. Subject has said to complainant that she "needs to talk english" and was "making fun" of her.
Offender has verbally abused AP being racial causing alarm and distress.
The AP and her girlfriend where in an Uber going to work. The AP's girlfriend rested her head on the AP's shoulder and the AP kissed her forehead. The subject has then started shouting at the AP and becoming aggressive, saying that it was disgusting and that they needed to get out of the Uber.
OFFENDER HAS BEEN POSTING THREATENING AND ABUSIVE MESSAGES ONLINE THAT THEY ARE GOING TO ASSAULT AND RAPE SOMEONE.
Offender has entered restaurant and taken left over food from tables, when asked to leave offender has become aggressive to staff and customers and made a homophobic comment UNKNOWN OFFENDERS HAVE DONE GRAFFITI ALL OVER THE BUS STOPS IN THE AREA AND SHUTTERS. USING HATE SLANG.
INFT has woken-up in the middle of the night and overheard AP recording a video to himself in the top-floor flat, complaining about "THE QUEER THAT LIVES NEXT DOOR".
Unknown offender mentions racist statement
Unknown male offender calls police and states what sounds like "ALLAHU AKBAR THE NIGGERS AND JAFAR YOU WILL NOT TURN FOR ME" and clears call.
Unknown offenders have approached AP from an unknown location on the road after AP got off of the bus. The offenders have then deliberately coughed towards AP and AP believes this is to imitate Coronavirus. The offenders have then made off via getting on the [REDACTED] Bus.
Known offender has become angry on the phone with the call handler and before hanging up said "you fucking faggot".
a/p is stood on the metro link platform with her mother waiting to go to school,she is wearing a school uniform unique to a Jewish high school, a group of 3-6 unknown boys wearing [REDACTED] school uniform are stood behind,one of the group says to another boy in that group "WHY ARE YOU EATING THAT DOUGHNUT YOU FAT JEW ",they then notice the a/p and

unknown male from same group says "oh look there's another one" All parties then board tram.
U/K OFFENDER/S HAVE BEEN DRIVING AROUND A JEWISH AREA. OFFENDERS HAVE A PALESTINIAN FLAG OUT AND ARE SHOUTING AT MEMBERS OF THE JEWISH COMMUNITY. OFFENDERS HAVE DRIVEN OFF IN AN U/K DIRECTION
Unknown offenders have refused to fit a carpet for the victim, the victim hears one on a phone call say they wont do it because he is disabled.
Male offender sends over 118 emails to a Council Parking team. The emails contain words of hatred towards white British people. The offender states the team are "CAUCASIAN BASTARDS" and "DO YOU BRITISH BASTARDS LIKE KNIFE CRIME, YOU TERRORISTS".
Unknown offender, a vehicle recovery driver, has been heard calling a customer "black c*nt".
- CHILDREN PLAYING AROUND WITH THE PHONE,ON PLAYBACK- " CHILD KEPT SAYING "NIGGER" MULTIPLE TIMES AND THEN STATED HE HAS BEEN RAN OVER THEN COULD HEAR HIM SHOUTING TO A MATE COME SAY HI I HAVE TOLD THEM I HAVE BEEN RUN OVER
Mr [REDACTED] has posted to his Facebook Page a picture of a vehicle stating a black female was driving it and was 'waving at him like an African Queen'.
WHILST ATTENDING OFFENDERS ADDRESS, OFFENDER HAS BECOME ABUSIVE TOWARDS AP. OFFENDER WAS POINTING FINGERS AT AP AND CALLED AP "POLISH BASTARD"
Known male offender who is ap's parents neighbour told ap's parents they are the only Muslims in the close and they are disliked.
HATE INCIDENT. Known offender lives next door to the AP. Offender has confronted the AP about a damaged bin. AP believes she has been targeted due to her race.
Unknown offender(s) have placed swastikas on lamppost in an area where a high number of the Jewish community reside.
Known male offender makes racist comments whilst he is inside his flat.
Hate Incident - Doctor was attending an appointment with a patient and her husband. Patient's husband told the doctor - "When you come to this country you should speak the Queen's English" in reference to the Doctor's accent/nationality.
Informant witnessed a road rage incident between 2 vehicles. Unknown male victim had right of way but unknown female offender wanted to go. Male went first and the female became abusive and called the male a 'paki'. They then went their separate ways.
Victim states male came up to her and said to her and her friend that she was with that they looked suspicious and dangerous and she believes that is due to her ethnicity and skin colour
The informant has seen 2 videos on YouTube. [REDACTED] where a protest camp has been set up opposite to the university in support of the Palestinians regarding the war and conflict in Gaza. In the video the YouTuber [REDACTED] calls people with headscarves at the free Palestine camp "terrorists" also calls the camp a " Hamas camp".
Unknown offenders have got on the bus at Ashton interchange and have been shouting homophobic language calling other passengers and people walking saying "faggots and gay". Offenders have also been using racial slurs saying "Paki and Asians".
AP was the victim of verbal abuse from another member. AP has since received a banning letter for the location and perceives this to be due to his race.
Ap emailed in to report that an named offender has approached the victim who was an invited guest at the club via the club from an unknown direction. The offender has then pursued a cause of conduct which amounts to hate crime which is racially motivated, as the offender was being aggressive, rude and verbally abusive towards the only two brown guest at the club. The offender told the the two brown guests to get outside paki fat cunt", and said to

them that "you shouldn't be here". The offender also threatened AP and the other brown person by saying that The offender said " fucking kill you" to AP and [REDACTED] who were the only brown people in there.
