I write in connection with your request for information dated 18/09/2024, received by Greater Manchester Police (GMP) for the following information:

I would like to request the following information:

1) Please can you provide the total number of non-crime hate incidents recorded by the Constabulary between August 30, 2023 and August 30, 2024.

If you do not have figures which are as recent as August 2024, can you please provide the figures for the most recent 12 month period for which data is available.

2) Please can you provide a redacted copy of the free text crime reports (described as modus operandi reports by many forces) for these incidents for August 2024.

If you do not have them for as recently as August, can you please provide them for the most recent month available.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

I am not obliged to supply you with all the information as an exemption applies.

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies. Part 2 is exempt from disclosure by virtue of the following exemption: **Section 40(2) – Personal Information.**

Where redactions occur, this represents information that identifies a living individual, to disclose this information would breach the principles of the GDPR and the Data Protection Act 2018. Personal data is defined by Article 4 of the GDPR and Part 1 of the Data Protection Act 2018 and means any information relating to an identified or identifiable natural person ('data subject'). An identified natural person is one who can be identified directly or indirectly from that data.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

- This data contains non-crime hate incidents with a created date between 30th August 2023 and 30th August 2024, excluding cancelled records. Further information about cancellations can be obtained from the Home Office Counting Rules.
- Non-crime hate incidents may have more than one motivation e.g. race and religion.

2. Redactions appear where you see XXX.

Unknown person approaches a taxi and began shouting verbal abuse.
Known XXX offender makes culturally insensitive comment towards AP and neighbours in the area.
Offenders were running trying to flag down a black cab. The cab/AP slowed down and when the offenders realised XXX wasn't available, one of the offenders shouted "you XXX " as the AP drove off.
Known offender/s has seen AP in her kitchen then proceeded down XXX path and Spat towards AP front door.
U/K person has submitted online report to police using false details containing racial comments
unknown XXX approx XXX squeezes her nose and makes sneezing nose whilst looking at AP
Offender has been on Tiktok live, and saying "lots of hateful comments",
the fire service attended to extinguish the fire and when warned about lighting them, the XXX said 'I do it as they speak Polish'
Unknown XXX says "why don't you speak british" towards 2 XXX
XXX preaching in a public location during gay pride weekend
YOU FOREIGNERS TAKE OUR JOBS. YOU XXX DON'T PAY YOUR TAXES'.
inft reporting named XXX has posted material which relates to the recent riots
Unknown offender on twitter sends AP a picture of a piece of card where they had written XXX and then their own user name underneath.
Subject posts online in support of Palestine,
INFT REPORTING HATE INCIDENT THAT TOOK PLACE YESTERDAY WHERE XXX HAS SHOUTED RACIAL SLURS

UNKNOWN OFFENDER DRESSED UP IN IDF UNIFORM, STANDING ON THE MAIN ROAD LOOKING INTO PASSING VEHICLES.
Off-road motor bike, drove through crowd of 30 runners waiting to start a warm up. Bike stopped and person on the back shouted 'XXX!' at the group
INFORMANT IS REPORTING POSTS ON SOCIAL MEDIA WHERE OFFENDER IS MAKING REFERENCES TO "TAKE THE COUNTRY BACK" AND "WAKING UP THE LION"
3rd party report from the XXX INFT with regards to a post on social media
Offender posts derogatory comments about the AP on social media referring to them as a 'XXX' and that XXX family are 'inbred'
Named facebook users have put racist, hurtful comments on a public facebook post which has caused victim upset.
Unknown XXX offender shouts racial slurs on street
Known offender who is subject to harassment of the informant impersonates a monkey
Named Offender makes a comment on a FB post about a XXX who had been stabbed to death -
Unknown offender(s) have placed a Nazi swastika sign up in a derelict shop window.
INFORMANT WAS IN THE CUPS AISLE IN TESCO AND NOTICED THAT SOMEONE HAD REARRANGED THE ALPHABET CUPS TO MAKE THE WORD "XXX".
Known subject has made several racial comments during several calls to the police
Unknown offender has told a passenger on the tram that they are going to get deported.
Unknown offender has posted a leaflet on Facebook which "tells people to get Zionists out of North Finchley" and AP has taken the word "Zionists" as Jewish People
Complainant has seen a Post online referring to a male being arrested during Riots ,
The AP is waiting for her daughter. The offender comes out of a house with a dog on a lead. The dog is taken off the lead when approaching the AP and growls at the AP. The AP is distressed but the offender does not intervene.
Known male offender racially abused AP shouting "fuck off you XXX XXX".
2 x XXX youths have walked passed the informants address and on seeing an LGBTQ+ poster on a wall they have shouted towards the address
Unknown male security at location asks XXX to leave the shop. XXX refuses and is removed from shop. XXX believes this is because the colour of skin.
suspect contact caller via tic tok and sates that "XXX is going to remove XXX from British society and put XXX in a cardboard box"
AP confronted Offender as to why XXX was not served and the next Customer was and the Offender became rude and unfriendly to AP.
DURING A VERBAL ALTERCATION WITH AP THE OFFENDER CALLS HIM " XXX"

AP states XXX was added to a group chat via Snap Chat which had members who had sent distressing threatening messages
U/K subject has left claimant a message. i hope you all die in lots of pain,
UNKNOWN OFFENDER HAS RACIALLY ABUSED THE UNKNOWN VICTIM
Offender was heard shouting at an unknown XXX and making racist comments
I was running on a wide piece of pavement. 2 XXX sharing the same bicycle shouted at me 'move out the way you immigrant'
UNKNOWN OFFENDER RINGS THE POLICE ON A 999 CALL. THE OFFENDER WAS VERY ABUSIVE ON THE LINE STATING XXX WANTED XXX PARTNER OUT OF CUSTODY.
Offenders hang banners with large swastikas on them, offenders then set up a table with leaflets and hand them out.
AGGRESSIVE XXX, A&E REPORTING A XXX IN A&E IS THREATENING TO "STAB" PEOPLE AND THREATENING TO "TAKE PEOPLE'S HEADS OFF".
