I write in connection with your request for information dated 20/08/2024, received by Greater Manchester Police (GMP) for the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information from your police force.

- 1) How many foreign nationals were arrested by this police force over the past 12 months?***
- 2) What type of offences and how many were committed by foreign nationals over the past 12 months?***

If the force cannot provide data for August 2024, could I request the information you do have for the last complete 12 months? i.e. August 2023 up to and including July 2024.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

The data provided is for the date range August 2023 to July 2024.

Question 1 – The total is 11,668.

Question 2

Due to low numbers being returned per offence type, I have provided the legislation of the arrest instead. Some of the totals have been replaced with X due to being low numbers, and as by providing all this information as you have requested would significantly increase the likelihood of identifying the individual(s) concerned, and as such the exemption under S40(2)

– Personal Information, would be engaged and result in information being refused. By replacing this data in this way, it can be provided in its entirety.
