Your recent Freedom of Information Request – Reference 01/FOI/25/014488/Y

GMP have received details of your request for information. Details of your request are provided below:

I am writing under the Freedom of Information Act 2000 to request any information held by Greater Manchester Police regarding [REDACTED] also known as [REDACTED], born [REDACTED]

[REDACTED] was my grandmother. She lived in Manchester in the 1950s and 60s and was in contact with Manchester City Council's Children's Department, as her son [REDACTED] was placed in foster care during that time.

Family contact with [REDACTED] slowed over time, and no one has heard from her since the 1980s. A private investigator once suggested she may have died in Manchester on or around 1 March 1996, possibly while living at [REDACTED]. However, I have not been able to verify this through documents.

I am hoping GMP may be able to confirm whether:

- Any missing person report or welfare check was ever filed for [REDACTED]*
- She was ever recorded as deceased or involved in a coroner's case*
- Any records exist from the 1960s-1990s that reference her*

If records exist but are exempt from disclosure, I would appreciate any high-level summary or guidance on next steps. My father and I have been, for many years, trying to uncover what happened to [REDACTED] We would be grateful for any information you could provide.

We have reviewed your request and considered it under the provisions of the Data Protection Act and Freedom of Information Act. Unfortunately, we are unable to provide you with the information you have requested in accordance with these information access routes. The reasons for this decision are set out below.

Data Protection Act 2018

The Data Protection Act (DPA) facilitates individuals' rights to personal data through the right of access provisions. Section 3(2) of the DPA defines personal data as information relating to an "*identified or identifiable living person*". As your request relates to information about an individual who is believed to be deceased, this means that your request cannot be considered under the access provisions of the DPA as it does not relate to personal data. Your request is therefore refused under the DPA.

Freedom of Information Act 2000

The Freedom of Information Act (FOIA) allows access to recorded information held by a public authority. Greater Manchester Police is a public authority defined by the FOIA and information we hold relating to deceased persons falls within the scope of this Act which may be considered for release. Your request has therefore been considered under the provisions of the FOIA.

Results

Greater Manchester Police can neither confirm nor deny that it holds the information you requested as the duty in Section 1(1)(a) of the Freedom of Information Act 2000 does not apply, by virtue of the following exemption:

Section 38(2) – Health and Safety

With Section 38 being prejudice based qualified exemptions there is a requirement to articulate the harm that would be caused in confirming or denying that the information is held as well as carrying out the public interest test.

Harm

Any information disclosed under the Freedom of Information Act is effectively released into the public domain, or to the 'wider world' and not only to the person making the request.

This request is seeking information regarding a named person whom you have stated is now believed to be deceased. As Section 40 is only appropriate for living individuals, it is not engaged for this request and therefore Section 38 is relied upon.

Factors Favouring Confirmation or Denial – Section 38

Confirmation or denial of the existence of the information would promote openness and transparency.

Factors Against Confirmation or Denial – Section 38

Confirmation or denial of the information relating to a deceased person would identify the individual and could subsequently cause distress and upset to the individual's close family and friends.

Balance Test

The release of information under Freedom of Information (FOI) is a release into the public domain and not just to the individuals requesting the information. Once information is disclosed under FOI there is no control or limits as to who or how the information is shared with other individuals, therefore a release under FOI is considered a disclosure to the world in general.

Confirmation or denial of whether Greater Manchester Police hold this information would amount to a release of information either on this occasion or on other occasions where a similar request is made. Whilst there is a public interest in the transparency of any information recorded by the police, there is also a strong public interest in maintaining confidence in GMP with regards to its handling of information. Information should not be released, if it is likely to have a detrimental effect on the physical or mental health of any individual, this includes the close family and friends of a deceased individual. It is for these reasons that the public interest must favour neither confirming or denying that the requested information is held.

However, this should not be taken as conclusive evidence that the information you requested exists or does not exist.
