FREEDOM OF INFORMATION REQUEST REFERENCE NO: 01/FOI/25/015236/K

I write in connection with your request for information dated 31/07/2025, received by Greater Manchester Police (GMP) for the following information:

Road traffic incidents for Gibfield Park Avenue/Gibfield park way including road traffic offences such as speeding from the past 5 years if possible

Meeting with [REDACTED] tomorrow to try and push for better road safety there due to a recent incident in which a car impacted a family home.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police to locate information relevant to your request. I can confirm that the information you have requested is held by Greater Manchester Police. However, I am not obliged to supply all the information you have requested as exemptions apply.

When refusing to provide such information because an exemption applies, Section 17(1) of the Freedom of Information Act 2000 requires GMP, to provide you - the applicant - with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies.

The requested information is exempt under **Section 21 – Information accessible to applicant by other means** and **Section 22(1)(a) – Information Intended for Future Publication**.

Transport for Greater Manchester publish reported road accident data for in an [interactive map on their website](#). This is up to date as of 31/12/2024. Information for early 2025 is expected to be published in June 2025. Consequently, this information is exempt under Section 22(1)(a).

Please contact TFGM directly if you have any further queries about the information on this map as it is owned and updated by them, not GMP.

As Section 22(1)(a) is a qualified exemption a public interest test needs to be applied.

Factors Favouring Disclosure

Disclosure of the requested information at the present time would allow the public to have access to the information immediately, would enhance public knowledge of the subject and would promote the accountability and aid transparency of GMP.

Factors Favouring Non-Disclosure

Reviewing and formatting the data at the present time, in response to a Freedom of Information request, would be a duplication of work and would involve a disproportionate use of GMP resources and would not be an economical use of public funds. Additionally, should the data from the upcoming report be released prematurely, there is the possibility that it may contain inaccuracies if it has not been subject to full scrutiny procedures.

Balancing Test

When balancing the Public Interest Test, we must consider whether the Public Interest is best served by the release of the information into the public domain immediately or by the withholding of the information. Arguments need to be weighed against each other. The most persuasive reason for disclosure is the facilitation of transparency of GMP, which needs to be weighed against the strongest negative reason, which, in this case, is the disproportionate use of GMP resources and an uneconomical use of public funds. Therefore, the stance at this time is that the requested data is exempt from disclosure in response to a Freedom of Information request due to its future official publication by GMP.

In accordance with the S17 of the Freedom of Information Act 2000, this letter acts as a Refusal Notice.
