- 1. A list of all police officers who are currently suspended on full pay, including their rank, the reason for their suspension, and the number of days they have been suspended.*

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP.

Due to low numbers being returned for some ranks, we have provided this information disaggregated and some of the totals have been replaced with X, as by providing exact figures as you have requested would significantly increase the likelihood of identifying the individuals concerned, and as such the exemption under S40(2) – Personal Information, would be engaged and result in information being refused. By replacing this data in this way, it can be provided in its entirety.
