Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP.

CAVEATS

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

The crime grand total was searched using Home Office offence codes 019/08, 019/12, 020/003 and 020/005 for the period 01/01/2023-31/12/2023. The Home office Offence codes relate to the following offences:
