I write in connection with your request for information dated 17/06/2025, received by Greater Manchester Police (GMP) for the following information:

***The ethnicity of those charged for pimping from 2001-2010, and then from 2011-2022***

**Result of Searches**

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

**Caveats:**

**In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.**

- Management of Police Information regulations state that non-essential records should be removed from police systems six financial years after the year in which they were originally created. This means that data that is more than six financial years old may be incomplete and should not be compared to more recent data.
- This data contains crimes recorded under the following offences with latest person outcome date between 2001 and 2022 (inclusive), where a person was charged, excluding cancelled crimes and crimes classified as fraud. Further information about cancelled crimes can be obtained from the Home Office Counting Rules. Details regarding fraud crime can be obtained by contacting the NFIB.
  - 024/03 Detention of a female in a brothel or other premises
  - 024/05 Person responsible for a girl aged under 16 causing or encouraging her to prostitution etc.
  - 024/06 Living off the earnings of prostitution; Exercising control over a prostitute
  - 024/11 Man or woman living wholly, or in part, off the earnings of male prostitution

- 024/17 Causing or inciting prostitution for gain
- 024/18 Controlling prostitution for gain
- 024/19 Keeping a brothel used for prostitution
- 071/08 Cause or incite the sexual exploitation of a child - Child 13 - 17
- 071/09 Controlling a child subject to sexual exploitation - Child 13 - 17
- 071/10 Arranging or facilitating the sexual exploitation of a child - Child 13 - 17
- 071/11 Cause or incite the sexual exploitation of a child - Child under 13
- 071/12 Controlling a child subject to sexual exploitation - Child under 13
- 071/13 Arranging or facilitating the sexual exploitation of a child - Child under 13
- 078/13 Trafficking in prostitution
- Some offences may only be available for part of this time period i.e. they may have started or stopped being used during this period.
- The same person may be counted in multiple ethnicities in this response as our system allows more than one ethnicity to be assigned to one person.
- The count in this response is the unique number of people so if the same person was charged more than once within this data-set they are only counted once (per ethnicity, as per the previous bullet point).
