- 4/ The gender breakdown of the applications made to courts to have domestic violence protection orders imposed.***
- 5/ The number of domestic violence protection orders applied for by GMP that were granted by the court. (successful applications)***

- The Gender breakdown relates to the Perpetrator & not the Victim.
- Where possible duplicates have been removed.
