I write in connection with your request for information dated 04/09/2025, received by Greater Manchester Police (GMP) for the following information:

I am writing to request information under the Freedom of Information Act 2000.

I would like to request the following information for the period of 2024, and 1 January 2025 to 2 September 2025: The total number of recorded sexual offences in your police force area, for 2024 and 2025 (to September).

The number of recorded sexual offences where the alleged perpetrator was not a British national, for 2024 and 2025 (to September).

If available, a breakdown of the alleged perpetrators by nationality, for 2024 and 2025 (to September).

If available, a breakdown of offence types (e.g., rape, sexual assault, harassment) allegedly committed by non-British nationals for 2024 and 2025 (to September).

If the information is not held in exactly this form, I would be grateful if you could provide the closest available information.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP.

CAVEATS

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

The time frames considered are 01/01/2024 to 31/12/2024 and 01/01/2025 to 09/09/2025.

The Home Office offence classifications used are Rape and Other Sexual Offences. More detail on the specific offences included in these classifications can be found in the [Home Office Counting Rules](#).

Due to low numbers being returned for some crimes and nationalities, some of the totals have been replaced with X, as by providing exact figures as you have requested would significantly increase the likelihood of identifying the individual(s) concerned, and as such the exemption under S40(2) – Personal Information, would be engaged and result in information being refused. By replacing this data in this way, it can be provided in its entirety.
