I write in connection with your request for information dated 26/08/2025, received by Greater Manchester Police (GMP) for the following information:

Under the Freedom of Information Act 2000, I would like to request the following information:

“The number of Greater Manchester Police officers convicted of criminal offences while in service, broken down by:

- Type of offence***
- Rank of the officer***
- Year/quarter of conviction”***

I would like this information for the last 5 years from 1 August 2025 backwards. If providing 5 years is not possible due to cost or availability, I would be grateful for the maximum period available, in the following order of preference:

- 1. 4 years***
- 2. 3 years***
- 3. 2 years***
- 4. 18 months***
- 5. 12 months***

If possible, please provide the information in a tabular electronic format (e.g., Excel or CSV).

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

Due to low results, the rank of each officer per each offence has not been provided, as by providing all this information split by individual rank as you have requested would significantly increase the likelihood of identifying the individual(s) concerned, and as such the exemption under S40(2) –

Personal Information, would be engaged and result in information being refused. By replacing the data this way, it can be provided in its entirety.

From September 2021 – August 2025, there have been 62 convictions. Some of these have been published in the media and some have not. For this reason the above statement has been applied to protect the identities of those not publicly named.
