I write in connection with your request for information dated 16/03/2026, received by Greater Manchester Police (GMP) for the following information:

REQUEST 1:

What would you like to know?: *What are the stop and search, and arrest quotas for* [REDACTED]

REQUEST 2:

What would you like to know?: *What are the average number of stop and searches, and arrests made by PCs in the Pilkington Park neighbourhood team, per month?*

REQUEST 3:

What would you like to know?: *How many stop and searches and arrests has* [REDACTED]
[REDACTED] *made each month, over the past six months?*

REQUEST 4:

What would you like to know?: *How many stop and searches and arrests has* [REDACTED]
[REDACTED] *made, each month, over the past six months?*

REQUEST 5:

What would you like to know?: *How many stop and searches, and arrests had* [REDACTED]
[REDACTED] *made by 29/01/2026 from the beginning of the month?*

- How many arrests and stop and searches were made on 30th and 31st, on each day respectively?

- Did he achieve his quota for arrests and stop and searches for January?

REQUEST 6:

What would you like to know?: *Where were* [REDACTED] *going on*
30/01/2026 at 18:00 on Old Hall Lane, Whitefield?

- What was their reason for attending [REDACTED] directly after making the arrest?
Do their notes or logs reflect this?
Is there any record of them disclosing the incident, stop and search, and arrest to a member of the public?

Relating to incident No. 2731 30/01/2026 occurred, STS/06A1/0000547/26 and CRI/06NN/0001510/26

REQUEST 7:

What would you like to know?: On page 2 of CRI/06NN/0001510/26, under MO details, the description describes [REDACTED] completing a "proactive patrol".

- Is this a routine patrol?
- How often are these completed along Old Hall Lane and Philips Park Road West?
- Are they scheduled?
- How many have been conducted over the past six months, on these roads?
- How many of these have [REDACTED] completed in this area in the last year?
- How many of those resulted in stop and searches, arrests and convictions?
- How many have been completed by any officer on these roads, since 30/01/2026?

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm some of the information requested is held by GMP.

However, I am not obliged to supply all the information as an exemption applies to **questions 2, 3, 4, 5, 6 and 7**

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies.

This request is exempted from disclosure under **Section 40(2) Personal Information** – this information constitutes personal data of an identifiable living individual/s, and to disclose this information would breach the principles of the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. Personal data is defined by Section 1 of the Data Protection Act 2018 and means data that relates to an individual who can be identified directly or indirectly from that data.

Section 40 is an absolute exemption with no requirement to complete a public interest test.

In response to questions 1 and part of question 5, GMP do not have stop and search quotas.
