I write in connection with your request for information dated 15/09/2026, received by Greater Manchester Police (GMP) for the following information:

Under the Iowa Open Records Act, Iowa Code Chapter 22 and as a member of the Media acting in the best interest of the public, I am requesting that you please provide all records that discuss or describe:

Charges: Grooming and enticing a minor under 16 for sexual purpose (Class D felonies); exhibition of obscene material to a minor (serious misdemeanor)

Location of Incident: not specified in available reporting

Location of Arrest: not specified in available reporting

REQUESTING: all bodycam footage for this case in video format. I want all bodycam footage from every officer involved in the arrest of [REDACTED] in connection with [REDACTED], the undercover online predator investigation conducted by the Manchester Police Department beginning in September 2025.

This includes any and all bodycam video connected to the incident — including footage from the undercover operation's culminating enforcement action, the physical apprehension and arrest of [REDACTED] taken into custody without incident, and the transport of [REDACTED] to the Delaware County Jail.

I am also requesting any recorded interviews or Mirandized statements provided by [REDACTED], including any such recordings, if they exist.

Lastly, I would like a copy of the full incident report, the arrest affidavit, the charging documents, and the statement of probable cause.

I request that these records be provided to me in electronic format via email or a secure file-sharing link to the email address provided below.

I confirm that this request for public records is being made for non-commercial purposes and is intended to serve the public interest. As a news agency, AllAboutCrime seeks to inform and educate the public about government accountability and transparency. The requested records will be used to produce educational and journalistic content shared on YouTube, which serve as modern forums for public discourse. While these platforms may be monetized, the primary purpose of this request is to benefit the public by providing access to critical information. I would request a prompt response to this request. If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
