I write in connection with your request for information dated 22/01/2026, received by Greater Manchester Police (GMP) for the following information:

I am writing to request access to and copies of all public records related to the incident on August 29, 2024, involving passenger [REDACTED] aboard a Jet2 flight from Manchester to Dalaman, Turkey.

Alleged Charges (as reported in media):

- *Being intoxicated on an aircraft*
- *Common assault of an emergency worker*
- *Assault by beating*

I am specifically requesting the following records:

Body-worn camera footage from law enforcement involved

- *Incident / offense reports prepared by airline or police personnel*
- *Arrest statements and police reports*
- *Court documents, including hearing transcripts and plea statements*
- *Statements from airline staff, flight attendants, and involved officers*
- *In-flight communications or 911 calls associated with the incident*
- *Use-of-force or restraint reports*
- *Any supplemental or follow-up reports prepared in connection with this case*

Timeframe of requested records:

August 29, 2024, through the present.

If any portion of this request is denied or redacted, please cite the specific statutory exemption relied upon. If records are available electronically, I request they be provided in electronic format.

Please advise in advance of any costs associated with fulfilling this request. If applicable, I request a waiver or reduction of fees as these records are sought for public information and news-gathering purposes.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate the requested information and I can confirm the information requested is held by GMP.

However, I am not obliged to supply all the information as an exemption applies.

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies.

This request is exempted from disclosure under **Section 40(2) Personal Information** – this information constitutes personal data of an identifiable living individual/s, and to disclose this information would breach the principles of the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. Personal data is defined by Section 1 of the Data Protection Act 2018 and means data that relates to an individual who can be identified directly or indirectly from that data.

Section 40 is an absolute exemption with no requirement to complete a public interest test.
