I write in connection with your request for information dated 09/12/2025, received by Greater Manchester Police (GMP) for the following information:

Under the Freedom of Information Act 2000, I request the following recorded information held by your force:

Please provide an anonymised spreadsheet (Excel or CSV) containing all recorded rape offences (including attempts) from 1 January 2020 to the most recent complete month available (or up to 31 December 2025 if already complete).

For each offence, please include the following fields (or the closest equivalent held on your records management system):

- 1. Financial/crime year (or date of recording/offence)*
- 2. Victim ethnicity (preferably using the 16+1 or 18+1 self-defined codes, or just White, Asian, Black, Mixed, Other)*
- 3. Victim age band (e.g. "Under 18" / "18 or over" / actual age if banded differently)*
- 4. Suspect/offender ethnicity (same coding as victim)*
- 5. Suspect/offender age band (same as above)*
- 6. Victim-offender relationship (e.g. Stranger, Partner, Ex-partner, Parent, Acquaintance, Family member, No suspect identified, etc.)*
- 7. Police district / borough / local policing unit / Basic Command Unit*

I have previously submitted a similar request to your force [FOI-30870-25-0600-000], but having now seen the full raw dataset released by West Yorkshire Police using the exact specification above, I am re-submitting this refined request in order to obtain the data in the same detailed, case-level format that has already been disclosed elsewhere. I believe this

precedent removes any remaining cost or privacy objections. If said request exceeds costs, I am more than happy for you to continue the original request.

I am content for personal identifiers to be redacted and for small cell counts to be suppressed if required for Data Protection reasons, but I do not require full anonymisation beyond that.

Please supply the data electronically.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP.

CAVEATS

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing – the systems are in continual development and the data provided for this request is what the systems currently hold. Any data provided for this request is subject to change as crimes are progressed and/or updated.

Victim and Offender reports were used with relationships to obtain the data, for the period Jan 1st 2020 until Nov 30th 2025. This was then filtered to all Rape offences.

Crimes are from when they were recorded and not committed, and Years are filtered to Financial April 1st to March 30th,

“Unknown” means that this field hasn't been populated on our operating systems, and Ethnicity is self-defined.
