I write in connection with your request for information dated 13/08/2026, received by Greater Manchester Police (GMP) for the following information:

I am making a request under the Freedom of Information Act 2000 for recorded information concerning [REDACTED], who was returned to the United Kingdom following her arrest in Tenerife and subsequently taken into custody at Manchester Airport.

I am specifically requesting:

1. *All available Greater Manchester Police body-worn video footage showing [REDACTED] during her return to the UK and subsequent arrest or detention at Manchester Airport.*
2. *All body-worn video footage recorded by every GMP officer who interacted with, escorted, detained, arrested, or transported [REDACTED]*
3. *Any police vehicle or police van video footage showing [REDACTED] following her arrival at Manchester Airport.*
4. *Any other video recordings made by GMP officers during the operation involving [REDACTED] at Manchester Airport.*
5. *Any photographs or other visual recordings created by GMP officers in connection with her return, arrest, detention, or transportation.*
6. *Any records identifying the GMP officers involved in escorting, arresting, detaining, or transporting [REDACTED].*
7. *Any available video or audio recordings showing [REDACTED] being escorted from the Manchester Airport terminal, placed into police custody, or transported away from the airport.*

For video and audio material, I am requesting the complete recordings rather than edited excerpts or short clips that may have been supplied to news organizations.

Please preserve all responsive body-worn video, police vehicle footage, photographs, audio recordings, reports, and electronic records while this request is being processed.

I would prefer to receive the requested records electronically.

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP. However, I am not obliged to supply you with the information as an exemption applies.

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies. The information you have requested is exempt from disclosure by virtue of the following exemption: **Section 40(2) – Personal Information.**

Section 40(2) represents information that identifies a living individual, to disclose this information would breach the principles of the Data Protection Act 2018. Personal data is defined by Section 1 of the Data Protection Act 2018 and means data that relates to an individual who can be identified directly or indirectly from that data.

Section 40 is an absolute exemption and there is no requirement to conduct a public interest test for such data.
