I write in connection with your request for information dated 05/12/2023, received by Greater Manchester Police (GMP) for the following information:

I would like to request the below in PDF format, broken down by either date or geographic location:

- *All reports of crimes which took place in cash-and-carries in your area between 30 November 2022 and 30 November 2023, including:*
 - o *Where the incident took place?*
 - o *What was reported to have happened?*
 - o *What outcome was reached (ie goods reclaimed, arrests made, sentences passed)?*

Result of Searches

Following receipt of your request searches were conducted within Greater Manchester Police (GMP) to locate information relevant to your request. I can confirm that the information you have requested is held by GMP. However, I am not obliged to supply you with all of the requested information as an exemption applies.

Section 17 of the Freedom of Information Act 2000 requires Greater Manchester Police, when refusing to provide such information (because this information is exempt) to provide you, the applicant, with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies. Where redactions occur in the table at the end of this letter, that is because that information is

exempt from disclosure by virtue of the following exemption: **Section 40(2) – Personal Information.**

Where Section 40 has been used, this represents information that identifies a living individual, to disclose this information would breach the principles of the GDPR and the Data Protection Act 2018. Personal data is defined by Article 4 of the GDPR and Part 1 of the Data Protection Act 2018 and means any information relating to an identified or identifiable natural person ('data subject'). An identified natural person is one who can be identified directly or indirectly from that data.

In accordance with the Section 17 of the Freedom of Information Act 2000, this letter acts as a Refusal Notice.

Caveats:

In July 2019, GMP implemented one of the largest IT infrastructure changes in UK policing. The systems are in continual development and the data provided for this request is what the systems currently hold.

This data contains crimes with a created date between 30/11/2022 and 30/12/2023, excluding cancelled crimes, where the crime location description, building, or custom text contains 'cash & carry' or 'cash and carry'. Further information about cancelled crimes can be obtained from the Home Office Counting Rules. Please note:

- The keyword methodology does not account for spelling errors.

We are aware of various issues affecting committed at locations for some crimes. These issues mean that data for a specific location may include crimes that did not happen in that location and/or exclude crimes that did.

- Some crimes do not have a beat code, which means that they cannot be mapped to other geographies e.g. districts.
- Some crimes have an incorrect beat code, which means that they are mapped to the wrong geographies.
- Some crimes do not have an address because e.g. the address has been recorded in a non-standard format or as map coordinates.

Please note:

- The address recorded may not be where the crime happened e.g. where the crime happened in the street and the address was used as a reference point.
- There may be more than one variation of the same address.

A crime outcome of 'Missing Value' means that the investigation is ongoing and an outcome has not yet been applied.

The information you have requested is in the table at the end of this document.
