Date	Rank	Allegation	Misconduct Meeting or Gross Misconduct Hearing	Outcome
08/06/21	Police staff	Taken indecent photographs of themselves in the workplace and sent these photographs, along with a naked photograph of themselves, to a colleague; in all of the photographs their GMP lanyard and/or ID badge can clearly be seen	Gross misconduct hearing	Final written warning
10/06/21	Police staff	Failed to follow a reasonable management instruction and not truthful with supervision when asked about the tour of duty	Misconduct meeting	No sanction
14/07/21	Police staff	A 'with cause' drugs test was conducted which provided a positive result for cocaine	Gross misconduct hearing	Written Warning
09/09/21	Police staff	Convicted of Permit to drive other than in accordance with a licence and Permit to drive without insurance. Further that when requested to stop by officers in a signed police vehicle they sought to mislead the officers by moving to the driver's seat and the driver moved to hide in the rear footwell.	Gross misconduct hearing	Disciplinary action imposed - would have been dismissed if still serving with GMP

15/09/21	Police staff	Accessed GMP data for non-policing purposes.	Gross Misconduct hearing	Disciplinary action imposed - would have received a final written warning if still serving with GMP
28/06/21	Constable	<p>Unauthorised access to police data regarding known sex workers, one of whom the officer then met twice.</p> <p>The officer was convicted of Misconduct in Public Office and sentenced to eight months imprisonment.</p>	Special Case Hearing	Disciplinary action imposed - would have been dismissed if still serving with GMP
09/06/21	Constable	The officer retired early from duty without permission.	Misconduct Meeting	Written Warning
09/07/21	Constable	<p>The officer engaged in sexualised correspondence with a member of the public, he met off duty, via social media.</p> <p>Some of the content included images of the officer with items of police uniform, one sent while on duty.</p>	Gross Misconduct Hearing	Final Written Warning
13/07/21	Inspector	The officer engaged in unwanted sexualised behaviour towards two lower ranking members of staff, off duty, at a social event.	Gross Misconduct Hearing	Disciplinary action imposed - would have been dismissed if still serving with GMP

19/07/21	Constable	<p>The officer was convicted of two counts of driving without due care and attention.</p> <p>The officer, off duty, drove in an inappropriate manner with children in the vehicle.</p>	Misconduct Meeting	Final Written Warning
23/07/21	Constable	The officer sent a picture of a deceased body, attended as part of their duties, to a member of the public for no policing purpose.	Misconduct Meeting	Written Warning
10/09/21	Constable	The officer, on two occasions, whilst off duty used unreasonable force against his partner.	Gross Misconduct Hearing	Dismissal without notice
