Inappropriate content on work issue mobile phone and made a homophobic comment about a colleague when on duty.	Hearing	Disciplinary Action- Would have been dismissed if still with GMP
30/05/24	Police staff	Subject to a with cause drug test which returned a positive result for cannabis.	Hearing	Disciplinary Action- Would have been dismissed if still with GMP
